## **SCHOLARSHIP & EOF APPLICATIONS**

The PA BPW Foundation is pleased to report that we are ready to accept 2011 – 2012 Scholarship Applications. The deadline is October 1, 2011 for the second semester scholarships. The Scholarship Applications and instructions can be found on the BPW/PA website at [www.bpwpa.org](http://www.bpwpa.org) under the download section. The completed applications and any supporting materials must be submitted in triplicate and mailed to Teresa A. Miller, 8 West Front Street, Media, PA 19063. Transcripts and Letters of Recommendations should also be attached to the applications.

Each year numerous scholarships are presented to worthy student applicants. The maximum scholarship is \$2,500.00 per winner, with three (3) scholarships awarded for the Fall semester and three (3) scholarships awarded for the Spring semester. During 2010 – 2011, a total of \$12,500.00 was awarded in scholarships.

The Edith Oler Flanagan Disaster Fund is a resource available to any BPW/PA member who has suffered a financial hardship caused by any reason, such as uninsured medical expenses, fire loss, termination of employment, etc. The awards are based on financial need. The PA Foundation has discretion in the amount of the award. PA BPW Foundation in awarding EOF funds, balances its fiduciary duty to its donors (our generous members) with the needs of the Edith Oler Flanagan applicants to arrive at an amount that helps members who are having difficulty. During year 2010 – 2011, a total of \$ 13,800.00 was given in Edith Oler Flanagan funds. If a member of your Local or District is suffering hardship and needs financial assistance, please have them consider applying to the Edith Oler Flanagan Fund. All applications are strictly confidential. There is no formal application for the Edith Oler Flanagan Fund. A summary of the present hardship and how the Edith Oler Flanagan Funds can help the member and the amount requested should be sent or emailed to Teresa Miller for consideration by the PA BPW Foundation Board.
